

Why human rights in the city?

Every state is obliged to respect, protect and fulfill human rights. In implementing this obligation the local level - the city - has an essential role: It is the place where people meet daily and the place where every decision concerns the human rights of individuals. To ensure that the human rights instruments are effectively applied and that specific problems are addressed locally, people must be involved in the shaping of the city. Understanding human rights is a precondition for citizens' participation in developing their human rights city: Only those who understand human rights can stand up for them and demand, protect and defend rights for themselves and others.

Human Rights Declaration of the City Graz:

The municipal council resolution of the 8th February 2001

„The City of Graz, especially the members of the city council and of the city government shall be guided in their actions by the principles of international human rights. Thereby the residents of the city, especially the youth, shall be informed about the established codes of human rights and about the rights and obligations derived therefrom. It is an objective, especially with regard to those who bear duties in public institutions, organisations and associations to respect and fulfill the human rights relevant standards in the daily life of the city. Deficits in the field of human rights are to be detected at all levels of society to respond appropriately. Thereby human rights shall play a major role in the guidelines and decisions for the future development of the City of Graz. With this declaration and with the aims and code of practice associated therewith, the City of Graz as the European Cultural Capital 2003 expresses its understanding of culture and human dignity.“



Institutions of the Human Rights City

Human Rights Council

The Human Rights Council consists of 30 members from politics, administration, judiciary, police, the media and civil society, who have been nominated by the mayor. The Council advises the municipal council and the mayor and supports the development of the Human Rights City critically.

Migrants' Council

The Migrants' Council is elected at the same time as the municipal council. It advises administration and politics and proposes solutions to political representatives for problems such as political and social disadvantages, the housing situation or educational issues.

Interreligious Council

The Interreligious Council of the City of Graz consists of representatives of all legally recognized religious communities and advises the mayor.

Department of Integration of the City of Graz

The Department of Integration works on measures for political, legal and social equality of nationals and non-nationals. It develops policies and projects to promote understanding of cultural pluralism in the urban public of Graz.

Graz Office of Peace and Development

The Peace Office is a competence center for non-violent co-existence in the city. The focus areas are dealing with conflict and violence management, preventing violence in and with schools, neighbourhood service and district service for conflict prevention and management.

European Training and Research Centre for Human Rights and Democracy – ETC Graz

ETC Graz is engaged in human rights and democracy education, research and consulting. As the Office of the Human Rights Council, ETC accompanies and coordinates the human rights city process and the ECCaR obligations of the City of Graz.

European Coalition of Cities against Racism – ECCaR

The Coalition of Cities is a UNESCO initiative to effectively fight racism, discrimination and xenophobia. Graz passes a Ten-Point Action Plan for periods of three years since 2006. The ECCaR office is at the Mayor's Office.
